Your kind cooperation is requested in adhering to the following.

1. Minimum deposit of 50% is required as a retainer at the time the wedding date is booked by the client.
2. The remaining balance is due 2 weeks prior to wedding date.
3. All deposits are nonrefundable, in the event of a date change or wedding cancellation by the client for any reason.
4. Proof album and CD with digital images will be delivered in approximately four weeks from the wedding date.
5. If Heather Morrissey is unable to perform to the guide lines of this contract due to a Fire or other casualty, act of God, act of terrorism, or other cause beyond the control of the parties, or due to a grave illness of photographer Heather Morrissey; and if Heather Morrissey Photography is unable to provide a photographer that is agreeable to the client, then all fees paid by the client will be returned in full, but Heather Morrissey Photography shall have no further liability with respect to the agreement. If Heather Morrissey Photography is unable to perform to the obligations in this contract for reasons outside the sole control of Heather Morrissey, she will not be liable for costs in excess of the amount the client has paid. This limitation of liability will also apply in the event that negatives or digital images are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost without fault of the photographer, Heather Morrissey.
6. The client will obtain proofs and/or digital images, which may be used for newspaper announcements. Images may be used for personal use only, and may not be sold or published without the written consent of Heather M.
7. All rights to images created by Heather Morrissey will remain with the photographer. Heather Morrissey reserves the right to display any photographs made in conjunction with this wedding as samples of her work for the purposes of window and showroom exhibit, advertising, promotion on the Internet, publication, instruction and professional competition.
8. Coverage plan times must be used consecutively. Time starts when Heather Morrissey arrives and the time finishes when the coverage time runs out.
9. Photographing any specific moment is not guarantee by Heather Morrissey Photography and she will not be responsible for any missed moments. The client may present Heather Morrissey Photography with a list of suggested photos, but Heather Morrissey is unable to guarantee that those suggested photos, or any image will be captured.
